What is in this release?	This release of Bp Premier includes the ability to privately bill patients who fit at-risk COVID-19 criteria, in accordance with government changes on September 30. See In this release on the next page		
Which version can I upgrade from?	You can upgrade to version Jade SP4 from Bp Premier version <b>Summit</b> (1.8.4.642) or later. To check the current program version that you have installed, select <b>Help &gt; About</b> .		
	If you are upgrading from an older version of Bp Premier such as Lava or Indigo, an Upgrade Checklist is available here.		
Which data update do I need?	You must install the <b>October 2020</b> Data Update or later before you can upgrade to version 1.10.3.908. To check the current data update that you have installed, select <b>Help</b> > <b>About</b> .		
Which database and operating system versions are supported?	Supported operating systems and database have not changed since Jade SP3.		
When should I upgrade?	Best Practice Software recommend running the program upgrade outside of business hours.		
How do I upgrade?	Upgrade instructions are included in this document.		
	IMPORTANT Upgrade every client in your practice network immediately after you upgrade the server.		
What do I do after upgrading?	No configuration is required after upgrade.

## Upgrade to Jade SP4 1.10.4.910

**IMPORTANT** Before you run a program upgrade on the Bp Premier server, ensure that any workstations in remote download mode have been synchronised with the server database.

You must have the October 2020 data update or later installed before you upgrade.

- 1. Back up your Bp Premier database before running the upgrade.
- 2. Download and run the latest Drug Update on your Bp Premier server computer.
- 3. Synchronise any remote clients with the Bp Premier server.
- 4. Log all users out of the server and all clients before you upgrade. Users may log back in after the upgrade is complete and the SQL server service has been restarted.
- 5. Download and run the 1.10.4.910 program update on your server and all clients.
- 6. Log back in to Bp Premier and resume use.

## In this release

#### This release includes:

- Removal of prompt for bulk billing criteria for patients as previously defined in The Health Insurance (Section 3C General Medical Services COVID-19 Telehealth and Telephone Attendances) Determination 2020 Subsections 5(1) and 8(4).
- Reinstatement of the ability to bill COVID-19 incentives separately allowing the practice to claim outstanding 10981/10982 items that might have been previously missed.

If you have not already upgraded to Jade SP3, you will need to familiarise yourself with our enablement materials for that release prior to upgrading to Jade SP4. Jade SP3 release notes are available here.

If you are using ePrescribing in your clinic already in Jade SP3, you will be able to continue to use this feature in Jade SP4 with no further action required.
